RECORD GROUP 60 ACCESSIONS EXAMINED AS PART OF THE WNRC PROJECT

1. 63B0188 (Copy of SF-135 and annotated SF-135 attached.) [Permanent. Draft schedule submitted.]

This accession contains the following series related to Closed Conscientious Objector Files:

- Docket Cards. Boxes 77-87. Consists of 5x8 index cards arranged by court district, thereunder alphabetically by name.
- Abstracts. Boxes 88-93. Consists of 3x5 index cards arranged numerically by case number (1-12387).
- Them 3 Subject Index. Box 93. Consists of 3x5 index cards arranged alphabetically by subject.
- State Index. Box 93. Consists of 3x5 index cards arranged alphabetically by State.
- Name Index. Boxes 94-100. Consists of 3x5 index cards arranged alphabetically by name.

Originally, the accession included 76 FRC boxes of the closed case files (3001-4999). Neither the SF135 on file in with NCWA nor the NARS-5 database contained any reference to the disposition of the case files. An annotated SF135 was later found in an older NCWA file (a copy of which was then placed in the proper file). The annotated SF135 stated that the case files were destroyed on November 23, 1971. The destroyed records were not covered by an authorized disposal schedule, rather the SF135 is annotated to reflect that "similar records previously disposed of by list."

These records warrant permanent retention and should be transferred immediately to NARA. Due to the small volume and potential for use, I can see no reason to defer transfer.

2. 68C5775 [Temporary, mixed. Dispositions already approved.]

This accession consists of two cubic feet of record and non-record material relating to training. The material includes correspondence, agreements, applications, nominations, and brochures which relate to the description of and department participation in: non-government training (FY1959-1964); Brookings Institution Conferences (FY1959-1964); Civil Service Commission courses (FY1959-1964); Rockefeller Awards (FY 1956-1960); and Legal Secretarial Training (FY 1956-1960). There is also information relating to requests from the University of Texas and the Montgomery County Public School district. The correspondence is typically addressed to Administrative Assistant Attorney General S.A. Andretta. The majority of the record material is covered by GRS 1/29/b. Some of the material is covered by GRS 14/1. As the retention period for both GRS items has expired, the records should be destroyed immediately.

3. 69C5921 (Copy of SF-135 attached.) [Permanent and Temporary. Disposition already approved? NC1-60-76-10, Items 1 and 2.]

This accession consists of press releases and speeches issued by the Department of Justice during part of 1967 and all of 1968.

Box 522. Master copies of Press Releases (January - December 1968). Arranged in folders by month, thereunder in reverse chronological order. Also includes copies of FBI press releases. Includes statements and addresses given by the Attorney General and the Assistant Attorney Generals. There are also copies of reports, photographs, and correspondence to which the releases refer.

The material in this box is permanent and should be transferred immediately to NARA. I do not think that the requests should be deferred as they fill a gap in some records that have already been transferred and are awaiting archival processing.

Box 523. Press Releases and Speeches (08/01/67 - 10/31/67). In envelopes, with reproduction orders.

Box 524. Press Releases and Speeches (11/01/67 - 02/29/68). In envelopes, with reproduction orders.

The records in boxes 523 and 524 are temporary.

4. 70D2980 (Copy of SF-135 attached.) [Temporary. Check with B.B. at DOJ for disposition.]

This accession consists of time and summary sheets (DOJ Form 197 and cover or transmittal memoranda) submitted by DOJ lawyers (March 10 through August of 1969). The sheets are arranged according to office and usually contain the following fields: Attorney name and ID#; Organization codes; dates; leave; deminiminis time; DOJ file#, Complaint #, or Claim #; U.S.C.; Cause of Action Code; time; and total time.

This accession contains non-record printed copies of Congressional bills, hearings, reports and acts relating to budgetary matters of the Department of Justice (appropriation Acts, Supplementary Appropriation Acts, Deficiencies, etc.). The material is arranged by fiscal year (FY 1920, 1922-1949). This accession was recommended for disposal by Henry Wolfinger in a November 30, 1990 memorandum to NCWA. The memorandum bears a notation of the same date made by Judy Barnes requesting that Allan Kovan review the recommendation, and schedule the records for April. Apparently the accession was not scheduled for disposal. This material should be destroyed immediately.

10. 72B3878 (Copy of SF-135 attached.) [Check with B.B. to see what approved disposition is being utilized at DOJ.]

This accession contains budget submissions (including justifications, estimates, supplements and deficiencies) to Congress (FY 1939-1949). They are typically in binders (marked: FILE COPY), and will occasionally include correspondence relating to priorities. The records were utilized by the Administrative Division (B&A). These records can't be covered by GRS 5 as they appear to have been created by a formally organized budget office above the bureau level.

11. 72V5616A [Disposition already approved.]

This accession includes three cubic feet. The first foot (and a small part of the second) is arranged according to a decimal file. The decimal begins with 311 (The power of appointment

and removal) and goes to 1200 (Finances). The records date from 1967 through 1971. However, most of the material dates from 1970. The majority of the information is addressed to Charles M. Odell, Chief Personnel Operation Section. The majority of the second foot is copies of material relating to a grievance filed by an employee. The last cubic foot relates solely to the removal of Chief Deputy Marshall Daniel Moore. It includes affidavits, originals, official transcripts, and his actual personnel file. These records are covered by GRS 1/3 and should be destroyed immediately.

These records were created by the Central Payroll Division. They include: SF1128-A (Payroll for Personal Services, Payroll Certification and Summary); bi-weekly FEGLI reports; and DOJ check issue listings. They are arranged by pay period, then by division.
