1.	<p>The Stocks and Bonds Intelligence Control Card File System was created in 1972 when the then General Crimes Section, the predecessor of the General Litigation and Legal Advice Section, was heavily committed to the investigation and prosecution of cases involving stolen and counterfeit securities. (The Privacy Act Notice on this system, CRM-021 is attached.) During 1975 the Section personnel assigned to litigate cases relating to stolen and counterfeit securities was diminished substantially and the special unit was eventually dissolved in April 1976. Since that date no name has been added to the system.</p> <p>The system is a manual index card system. A copy of a blank card is attached. In all there is approximately 1.3 cubic feet of such cards. All information contained on the cards has been extracted from investigative reports which are contained in the regular files of the Criminal Division.</p> <p style="text-align: right;">(cont)</p>
