1.	<p>The Task Force on Violent Crime was established by the Attorney General on April 10, 1981 to recommend measures that the Justice Department could take to increase its effectiveness in combatting violent crime, and to enlarge the Federal Government's role in this effort through changes in legislation, increase funding of anti-crime measures, etc. The final report of the Task Force was issued on August 17, 1981.</p> <p>Correspondence files consisting of letters from citizens in support of more effective measures to control violent crime, commenting on one or more of the Task Force's recommendations, and on related matters, together with the response from the Associate Attorney General or another designated official.
