	<p align="center">SECURITY RISK ASSESSMENTS</p> <p>The Public Health Security and Bioterrorism Preparedness and Response Act of 2002 (Bioterrorism Act), Public Law 107-188, was enacted on June 13, 2002. Under this Act, the U.S. Department of Agriculture (USDA) and the U.S. Department of Health and Human Services (HHS), in consultation with the Attorney General (AG), established safeguards and security requirements for possessing, using, or transferring select biological toxins and/or agents. In April 2003, the AG tasked the Federal Bureau of Investigation's (FBI) Criminal Justice Information Services (CJIS) Division with conducting security risk assessments on candidates who have contact with select biological agents and/or toxins. Candidate scientists who work at public and private entities under the control of the USDA and the HHS are the primary subjects of the security risk assessments; however, assessments are also conducted on those individuals working at Department of Energy (DOE) laboratories, Department of Defense (DOD) installations, and university research facilities.</p> <p><i>cc Agency [unclear]</i></p>

	<p>Individuals that possess, use, or transfer select biological agents and toxins are required to submit a Bioterrorism Preparedness and Response Act FBI Information Form (FD-961) and a set of fingerprints to the CJIS Division. CJIS then searches several internal databases, including the Integrated Automated Fingerprint Identification System (IAFIS) and the National Crime Information Center (NCIC) System, as well as external databases such as the DOD's dishonorable discharge records and the Bureau of Immigrations and Customs Enforcement's (ICE) registry of illegal/unlawful aliens. These searches assist in determining if the applicant is restricted from working with biohazardous material. The restrictions that prevent an applicant from obtaining access to certain biological agents and toxins are defined in Title 18, United States Code (U.S.C.), Section 175b. Assessment results are forwarded to the employing department or agency indicating whether or not the applicant is restricted from working with biological agents and/or toxins.</p> <p>Security risk assessments are tracked through a Microsoft Access database. Individual case files are also created for each applicant.</p> <p>A. SECURITY RISK ASSESSMENT CASE FILES</p> <p>Records related to the processing of individual applications for access to select biological agents and toxins.
