	<p><b>White House Investigation/Name Check Consent Forms</b></p> <p>From 1996-2001, the Office of General Counsel's Administrative Law Unit (OGC/ALU) reviewed and approved approximately 30,000 background consent forms for individuals subject to FBI background investigations or name checks. These checks were part of the corrective process initiated after "Filegate." White House requests for name checks and background investigations were accompanied by a consent form signed by the subject and by the White House requesting official. Each form was reviewed by OGC/ALU and forwarded to the unit responsible for conducting the name check or background investigation. OGC/ALU retained a copy of the consent form for reference purposes.</p> <p>The unit tasked with performing the name check or background investigation filed the original consent form and related records in a Classification 161 file. OGC/ALU was removed from the review process in 2001.
