	Request for Destruction Authority for Serials (Documents) contained in Closed Newark Case File 281A-NK-92575 The Federal Bureau of Investigation is in the possession of a Federal Pre-Trial Diversion Program (PTD) court order, which mandates the removal of all records related to the subject of the court order from the FBI's central records system. Newark Field Division Office of Origin File 281A-NK-92575 contains serials related to the subject of the court order. However, cases opened in Classification 281 after 1995 do not have a NARA approved disposition authority. Therefore, the FBI requests permission to destroy serials in this unscheduled case file in order to comply with the requirements of the Federal Pre-Trial Diversion Program (PTD).
