	<p style="text-align: center;">Subscription Management System</p> <p>The Federal Bureau of Investigation (FBI) has implemented a new process to provide the public with better service and access to relevant information by proactively delivering e-mail alerts whenever web pages on the FBI's public website (www.fbi.gov) are updated. Customers can sign up online to receive e-mail notifications of updates to approximately 150 content areas, including the Ten Most Wanted list, news releases, etc. This subscription management system is maintained by a vendor, who hosts the e-mail address list and maintains records of each user's subscription options. No personal information other than the e-mail address is collected or maintained.</p>

Inputs: Website visitors complete an online form, which contains fields for their e-mail address, password (optional), and subscription options.</p> <p>Disposition: See instructions in item 2 below.</p> <p>2. Master File: The subscription management system maintains a record of the user's email address, password (optional), and his/her selected notification options.</p> <p>Disposition: DELETE e-mail address, metadata, and related records from the system upon user's termination of his/her subscription.</p> <p>3. Outputs:</p> <p>a. Notification alerts: Automated notifications are sent to subscribers whenever a webpage is updated. A record of each alert is maintained along with a list of recipients.</p> <p>Disposition: DELETE/DESTROY when 10 years old or when no longer needed for administrative purposes, whichever is later.</p> <p>b. Statistical reports: Reports on the number of subscribers, most popular content areas, etc.</p> <p>Disposition: DELETE/DESTROY when 5 years old or when no longer needed for administrative purposes, whichever is later.</p> <p>4. System Documentation:</p> <p>Disposition: DELETE/DESTROY when superseded or obsolete, or upon authorized deletion of the related master file.</p>
