| | The Federal Bureau of Investigation (FBI) is in receipt of Federal Pre-Trial Diversion Program (FPDP) court order, which mandates the removal of records related to the subject of the court order from the FBI's records system. Dallas file 46B-DL-87279, which pertains exclusively to the investigation of the subject of the court order, may meet the criteria for permanent retention if it is part of a systematic informational sample for file classification 46. However, the statistical sample set for classification 46 has not yet been determined by NARA. Additionally, file classification 46 cases not meeting the criteria for permanent retention may be destroyed when twenty year old. This file was closed on 1/8/2004, and therefore, has not yet met the required retention period.
