

	Collection of Photographs Related to Major Bombing Incidents & Other FBI Cases 1. Major Bombing Incident Photograph Collection The collection includes photographs of actual crime scenes, artifacts recovered and evidence of major bombing incidents. The photographs are organized by incidents and currently include, but are not limited to, Pentagon and Twin Towers Bombing, Oklahoma City Bombing, Kenya Bombing and Tanzania Bombing. The current volume of the Major Bombing Incident Collection is approximately 1,400 CDs and 300 binders. There is an index of the CDs and binder by incident, location of bombing, laboratory number and what the photographs contain. This collection includes copies, the original photographs are retained/destroyed commensurate with the retention period approved for the related case file.
