These laws are designed to protect the civil rights of all citizens and persons within the United States' territory. The program is divided into four subprograms that include Hate Crimes, Color of Law, Human Trafficking, and Freedom of Access to Clinic Entrances (FACE).</p> <p>The 1994 Freedom of Access to Clinic Entrances (FACE) Act makes it a federal crime to injure, intimidate, or interfere with those seeking to obtain or provide reproductive health care services. That includes not just murder, assault, arson, and property damage, but also death threats, burglaries, harassing phone calls, hate mail, and blockades.
