	<p style="text-align: center;"><b>Classification 306 Serial Killings</b></p> <p>The Federal Bureau of Investigation (FBI) established Classification 306 ("Serial Killings") in 1999 under the Violent Crimes and Major Offenders Program, Violent Crimes Sub Program</p> <p>In 1998, the United States Congress enacted the Protection of Children from Sexual Predators Act. Under Section 701 of that Act, Congress granted the FBI the specific authority to investigate serial killings at the request of the head of a state or local law enforcement agency. Congress placed that authority at 28 United States Code (USC) Section 540B. Section 540B defines serial killings as "Three (3) or more killings, not less than one of which was committed within the United States, having common characteristics as to suggest the reasonable possibility that the crimes were committed by the same actor or actors."</p> <p>FBI Offices process requests from state, local, and international law enforcement agency heads for FBI investigations of cases involving serial killings only when a formal written request for such an investigation from the head of a state, local, or international law enforcement agency with appropriate jurisdiction is received. In cases involving murders in multiple jurisdictions, only the head of one of the state or local agencies involved is required to submit a written request. The FBI closely coordinates the investigation with all of the agencies involved in the matter.
