

## **Classification 62 - Miscellaneous Subversive – pre-Universal Case File Number (UCFN)**

This schedule covers Classification 62 case files. Classification 62 contains records starting in 1921 and covers a large variety of cases. The miscellaneous nature of Classification 62 requires that the National Archives and Records Administration (NARA) must select permanent cases on a case by case basis.

### **1. Headquarter Files - Significant Case Files**

Significant case files related to organized labor, organized crime, liaison with federal agencies and foreign governments, cases in which the Director took significant personal interest, and cases about famous people, events and notorious offenders. Additional subjects include cases related to Federal Judiciary investigations, unreported interstate shipments of cigarettes, conspiracy against the U.S. government, misconduct by Department of Justice officers or employees, files on sources of information or informants, and files regarding publicity about the Bureau. Also included are cases relating to the Fair Credit Reporting Act, the Kickback Racket Act, Contract Work Hours and Safety Standards Act, Federal Cigarette Labeling and Advertising Act, Soldiers' and Sailors' Civil Relief Act of 1940, the Tariff Act of 1930, and the Fair Labor Standards Act of 1938. Examples of chronic correspondence, crank mail and civil matters are also included. Files selected by NARA.

DISPOSITION: PERMANENT. Transfer to NARA when 25 years old.

### **2. Headquarter Files - Routine Case Files**

Routine case files consisting of routine requests for publications, autographs and photographs, routine investigations into a civil matter, crank mail, mail from chronic correspondents, routine Congressional constituent mail, requests from citizens for FBI investigations which do not fall under the jurisdiction of the FBI, preliminary investigations that contain little or no documentation of an investigation, and Land Division matters, in which the FBI furnished information to expedite litigation. Files are identified by NARA.

DISPOSITION: Temporary. Destroy when 20 years old.
