

1.	<p>Pornographic Materials Reference File (PMRF).</p> <p>PMRF consists of slides, tapes, film, books, magazines, newspapers, photographs, and other media seized as the result of official investigations and forwarded to Federal Bureau of Investigation Headquarters by field offices, or submitted by social/civic organizations for reference. Primary interest is directed toward commercially-produced pornographic material as opposed to amateur productions. The material is routinely returned to the contributor. The collection consists of 500 cubic feet, and an additional 160 cubic feet are maintained in separate, inactive storage. The file is supplemented by indices arranged alphabetically by title/number, subtitle, and company/distributor, with cross-referencing. The indices are currently being converted from a manual to an automated mode.</p> <p><u>DESTROY</u> when administrative needs have expired, along with related retrieval devices.</p>
