1.	<p>"Sound Recording Reference File"</p> <p>The SRRF is a collection of phonorecords maintained at Federal Bureau of Investigation (FBI) Headquarters which was established in 1976 and voluntarily provided by various manufacturers. The collection was used for comparison with counterfeit and pirated phonorecords which were seized during the course of investigations by the FBI. The collection consists of approximately 5,000 8-track tapes. The FBI did not contribute to the contents as the file has been maintained in an inactive status for over two years. The FBI's need for the file has expired, and future demands will be satisfied by securing authentic phono records on an ad hoc basis.</p> <p>DESTROY when obsolete or superseded.</p> <p>Destroy existing phonorecords immediately. Destroy phonorecords acquired hereafter on an ad hoc basis when obsolete, or superseded or when current agency use ceases.</p>
