GENERAL AGENCY MISSION

UNICOR is the legal trade name for the Federal Prison Industries (FPI), a wholly-owned; Government corporation established by Congress on June 23, 1934. Its mission is to employ and provide job skills training to the greatest practicable number of inmates confined within the Federal Bureau of Prisons, contribute to the safety and security of our Nation's Federal correctional facilities by keeping inmates constructively occupied, produce market-priced quality goods and services for sale to the Federal Government; operate in a self-sustaining manner; and minimize FPI's impact on private business and labor

PRODUCT SUPPORT CENTER (PSC)

The Product Support Center (PSC) provides development, testing, cost analysis and technical training for UNICOR/FPI manufacturing. Although physically located at the Federal Correctional Institute in Englewood, CO, it is a component of UNICOR's Quality, Engineering and Operational Support Branch. PSC assists all major manufacturing areas such as clothing, textiles, office furniture, industrial products, and electronics. The Center is also involved in all new product development, including the analysis of manufacturing feasibility in a correctional setting. Product testing is carried out to ensure conformity to Federal, industrial and military standards, as well as compliance with environmental regulations. PSC staff also assists with new product implementation, work flow and efficiency studies at factory sites.

1. PSC eDRAWING SYSTEM:

A Central depository of all product drawings created by all business units in UNICOR such as clothing, textiles, office furniture, industrial products, and electronics, regardless of factory mission or geographical location. Drawings also originate from UNICOR's business partners.

- A ~~INPUT. Paper drawings ranging from A to E size in format, which are scanned and converted to imaging (TIF, PDF) or vector graphics (AutoCAD CAD/CAM) (GRS 20 Item 2a(4))~~

~~Disposition: Temporary Destroy after the electronic record and equivalent has been produced and verified~~

B OUTPUT Electronic reproduction of electronic drawings, production reports, information logs, and inventory reports

Disposition. Temporary Destroy when no longer needed for reference purposes

C DATA Electronic TIF, PDF, and CAD/CAM files containing product drawing information including initial drawings, revisions, and associated metadata, as available

Disposition. Temporary Cutoff when corresponding product is no longer in production or active maintenance status. Destroy 5 years after cutoff
