1	<p>This is a one time proposal related to numerous inmate case files previously transferred to the FARC by the USP, Atlanta Georgia. Please see attached correspondence for clarification and listing of involved accessions.</p> <p>For the files shown in the accession number list, we propose to change the disposal from the present "30 years from expiration of sentence, NC-129-77-11" to "destroy 30 years from release date. In essence we propose to consider the release date as the date of expiration of sentence. Noted are certain accessions that are excluded because they fall under the long term retention (pre-1920 files) as provided in NC-129-77-7 which requires retention until 2025.</p> <p>Typically, only 44 percent of inmates released would have had a small period of time remaining until expiration of sentence, generally 2 years or less. Compared to the overwhelming burden of reviewing each file in each box, then refile by expiration dates, this potential "early" disposal would not present research, legal, or administrative problems.</p> <p><i>Copy to agency + to NRC, 3/26/85.
