SUMMARY

This job provides for disposal of four series of records pertaining to the trademark program of the Office of Alien Property Custodian and its successors, 1942-63. The records document routine administrative transactions such as the licensing of trademarks and collection of royalties. Like similar records documenting the copyright and patent programs (Job No. N1-131-86-13 and -19), these records do not have sufficient value to warrant preservation. NNF and NNFG agreed with the appraisal of the records in reviewing this and other schedules for OAP records in 1983-85 (a copy of the documentation relating to the review of the appraisal is contained in Job No. N1-131-86-8).
