	<p align="center"><u>BUREAU OF JUSTICE STATISTICS</u></p> <p>The Bureau of Justice Statistics (BJS) collects and reports on statistics that describe all aspects of the justice system. Attendant to those functions, BJS administers contracts with individuals and organizations that process records provided by local or State agencies. As grant administrator BJS assumes control of the official records, and of the computer tapes on which they are stored, when a contractor defaults on the agreement. The records represent individual-level data on parolees collected by the National Council on Crime and Delinquency from each participating State in the Uniform Parole Reporting Program. There are two forms per parolee: an <u>entry form</u> for those discharged from prisons and placed under parole supervision; and, a <u>follow-up form</u> to maintain information on the status of each parolee after entering supervision, form UPR 2 (FU) OMB No. 1121-0065. These records were used for statistical purposes to describe entering parolees each year and to assess their performance while under supervision. This series is no longer maintained in this form and the continued archival of these records is no longer required. The government contractor who collected these data has been terminated and is no longer conducting this statistical collection for the U.S. Government.
