ATF RCS 101, Item 145, Out of Business Records Imaging (OBR). OBR is a system used to simplify the process and decrease the amount of time it takes to trace a firearm that was sold by a licensed Federal Firearm's Dealer that has gone out of business and submitted their records to the National Tracing Center (NTC), Out of Business Records (OOB) section.

- a. Master File. These records contain information on firearms such as: license numbers, serial numbers, caliber/type of weapon, and dates weapons are sold by the OOB dealer.

DISPOSITION. TEMPORARY. DESTROY WHEN 50 YEARS OLD OR NO LONGER NEEDED FOR AGENCY USE, WHICHEVER IS LATER.

- b. Input (Paper Records). Paper records, which consist of firearms information gathered from ATF F 4473 (Firearms Transaction Record), acquisition, and disposition forms entered on a daily basis.

- c. Output Records. In-house statistical reports are generated by the system periodically to contract and National Tracing Center management.

- d. System Documentation. Electronic copies include: functional requirements, internal design, and external design documents; implementation, data conversion, and test plans, users and maintenance manuals.

DISPOSITION. TEMPORARY. DESTROY WHEN SYSTEM IS OBSOLETE OR SUPERSEDED.

- e. Electronic Mail and Word Processing System Copies. Records created and received on electronic mail and word processing systems, and used to generate a record keeping copy. Also, includes electronic records maintained for updating, revision or dissemination.

1. Records that have no further administrative value after the record keeping copy is made. Includes copies maintained by individuals in personal files, and personal electronic mail directories on hard disk or network drives and copies on shared network drives that are used only to produce the record keeping copy.
