


1	Variance, Determination, and Exemption Files (Firearms and Explosives) These are file copies of all firearms or explosives variances, determinations, and exemptions granted by ATF Headquarters (i.e., Chief, Firearms Industry Programs Branch, Chief, Explosives Industry Programs Branch, or Chief, Firearms Technology Branch, Firearms and Explosives Industry Division) Federal firearms licensees (FFL) and Federal explosives licensees or permittees (FEL/P) who wish to use an alternate method or procedure, including alternate magazine construction standards, must obtain ATF approval for a variance from the firearms or explosives regulations under ATF's jurisdiction. ATF variances remain in effect until no longer required by the licensee/permittee, rescinded by ATF, or superseded by another variance or ATF ruling. In some cases, a variance may be transferred, e.g. with a change of company name, etc. ATF must retain variance files, including both incoming requests and ATF response letters, in order to assist Industry Operations Investigators in determining regulatory compliance, to aid in revocation hearings, to ensure both secure storage and the adequacy of business records, etc., and as record of precedence for ATF rulings. Similarly, ATF-issued exemptions and determinations remain in effect until rescinded by ATF, superseded by another ATF letter, or until a change in the product or practice renders void the exemption/determination. In these cases, it is necessary to retain both incoming and outgoing correspondence as record of precedence for ATF rulings and in order to adequately respond to requests from other regulatory authorities, Congressional inquiries, U.S. Customs officials, Consumer Product Safety Commission, etc.	N/A
