DESTROY when 40 years old.</p> <p>B. Label applications dated July 1977 and later. DESTROY when 5 years old.</p> <p>These labels are color micro-filmed at the FRC, Suitland, MD. No duplicate micro-film copy was made of the labels dated July 1968 through June 1977, therefore the hard copy is to be retained until 40 years old. Retention of the hard copy is more cost-effective than re-micro-filming all the labels to provide a back-up copy.</p> <p><u>SEE ATTACHED STANDARD FORM 115-A FOR REVISION. July 1977 and later. DESTROY WHEN 40 YEARS OLD.</p> <p>d. Color microfilm copy of label applications. July 1968 and later. HOLD ON-SITE. DESTROY WHEN ALL REFERENCE NEEDS HAVE ENDED.</p> <p>These label applications are microfilmed in color at the Washington National Records Center. Because only one color microfilm copy of the paper originals dated July 1968 through June 1977 has been prepared, the paper originals must serve as the security copy for the 40 year retention period. Retention of the paper originals is cost effective because the cost of preparing a duplicate color microfilm copy far exceeds the storage costs of the paper originals.</p>	NCI-436-77-1
