

2. Subject File of the Solicitor Relating to Immigration and Naturalization, 1933-40. 5 cubic feet. Arranged by an alpha-numeric subject classification scheme or congressional bill number.

Correspondence from the Solicitor's Office concerning legal aspects of immigration and naturalization, selected transcripts of testimony from trials of suspected violators of immigration regulations, particularly those suspected of being "Communists", case files regarding legislation to help individual immigrants remain in the United States, and internal memorandums and correspondence about proposed legislation. These files include material on the treatment of suspected radicals and leftists, the use of immigration laws to deport "undesirable" elements, immigration from Eastern Europe and especially Nazi-Germany, and general handling of immigration problems.

Affidavits, letters, transcripts of administrative hearings, blueprint drawings, photographs, mimeographed publications, congressional documents, and miscellaneous publications, concerning the firing, harassment, and physical beatings of union representatives or employee labor representatives at three large coal and steel companies: (1) the Harlan Wallins Coal Corp. of Harlan, Kentucky (1935), (2) the Carnegie Illinois Steel Corp., with plants in Chicago and Gary, Indiana (1937), and (3) the Sharon Steel Hoop Co. of Lowellville, Ohio (1937).

Correspondence, memorandums, draft labor agreements and legislation, reports, consular dispatches, and litigation files plus newspaper clippings, articles, and miscellaneous publications, telegrams, charts, maps, photographs, and contract documents, concerning all types of programs, legislation, rules, regulations, lawsuits, strikes, and disputes over the handling of foreign agricultural workers and migratory laborers from the early period under the Wagner-Peyser Act of 1933, which established standards for the recruitment of migratory workers, right up through the organization of migratory workers in the grape industry by Cesar Chavez in the late 1960s.

5. Subject File Relating to Civil Rights, 1957-71. 13 cu. ft. Arranged by subject or name of litigant.

Letters, telegrams, memorandums, court filings, briefs, motions, decisions, exhibits, reports, interviews, application forms, contracts, copies of legislation, newspaper clippings, articles, and miscellaneous publications concerning mainly the anti-discrimination efforts by the Office of the Special Assistant to the Solicitor for Civil Rights who provided legal services to the Manpower Administration and the Office of Federal Contract Compliance within the Labor Department. Includes comparative data on how whites and Blacks have fared in various areas of employment. Legal services rendered were primarily in relation to fair employment practice provisions of the Civil Rights Act of 1964 which prohibited discrimination in programs financed by grants

from the Department of Labor. Among these programs were the Neighborhood Youth Corps, Job Corps, and employment security agencies in the states which were funded by Labor. Particular attention was given to assisting the Office of Federal Contract Compliance in its mandated task of preventing job discrimination on Government contracts.

Contract applications, amendments, revisions, publications, memorandums, letters, reports, studies, telegrams, rules, regulations, congressional bills, state bills, and miscellaneous government publications concerning companies, community action groups, universities, city and municipal bodies making application to the Department of Labor to obtain contracts and funding under the Wagner-Peyser Act, the Area Redevelopment Act (ARA), and the Manpower Development Training Act(MDTA).

7. Subject File of the Solicitor's Office, 1945-63. 12 cu. ft. Arranged alphabetically by subject, name or type of document.

Consists of official correspondence, internal memorandums and reports, personnel lists, labor legislation and comments, labor related court rulings, press releases, speeches (particularly statements made in Congressional hearings), newspaper clippings, statistical reports, miscellaneous public and private publications and labor agreements. These files cover a wide variety of subjects including delegations of authority for the Secretary of Labor and other top labor officials (dating back to 1913), labor legislation, Mexican labor, wage laws, physically handicapped in the workplace, race and age and sex discrimination, union organizers and labor-management relations, Federal reorganization plans, employment of returning veterans from WWII, loyalty programs, statistical and narrative descriptions of field operations, internal changes and reforms in the administration of various laws within the purview of the Solicitor, and interpretations and opinions on fine points of law.

Correspondence, memoranda, wage determination decisions, labor agreements both published and in letter form, tables of wages and data provided for wage determinations concerning the attempts by the Solicitor's Office and regional attorneys to apply Davis-Bacon Act regulations on prevailing wages to the area of shipbuilding contracts in instances where the site of construction was known. The wage determination decisions cover all major shipyards on the Atlantic, Pacific, the Gulf, Hawaii and the Great Lakes.

9. Records Relating to the Federal-Aid Highway Act, 1953-61. c. 5-6 cu. ft. Arranged alphabetically by state and thereunder by county; usually there is also a folder for each state marked "statewide" covering projects involving two or more counties.

Reports of wage agreements and wage determinations for a variety of occupations varying from state to state, , copies of actual payrolls, copies of union contracts, requests for wage determinations; memorandums, correspondence, telegrams relating to proposed and actual wage decisions; union affidavits, contractor documents, annotated maps and surveys taken of highway construction wage rates; and promotional materials from unions, contractor associations, towns and state highway departments publicizing their points of view, EXCLUDING Contractor's Report of Construction Wage Rates which will be removed during archival processing. These documents mainly concern the Solicitor's efforts through its regional offices and local contacts to monitor the progress or lack thereof in the implementation of wage decisions promulgated by the Secretary of Labor at the state and local level to do mainly with federal highway construction mandated by the Federal-Aid Highways Act of 1956. Additional types of federal contracts covered by these particular records include the building of bridges, hospitals, schools, and all types of military facilities as well as some airport construction. Each of these activities is covered by appropriate legislation which mandates the Solicitor's active supervision in assuring prevailing wages, hours and safe working conditions.

Published transcripts of committee hearings, published studies and manuscripts, wage decisions, memorandums, reports, letters, telegrams, and statistical documents concerning Industry Committee hearings held in Puerto Rico under the auspices of the Labor Department and to establish equitable wage scales in selected Puerto Rican industries in accordance with the Fair Labor Standards Act and the Administrative Procedures Act. At the hearings, both Labor and business firms presented testimony about the competitive advantages and disadvantages to be gained from wage hikes for particular trades.

11. Legal Opinions, Rules, Regulations, and Legislative Interpretation Files Concerning the Establishment of Unemployment Compensation Offices, 1936-52. 17 cu. ft. Arranged alphabetically by state and thereunder chronologically by date.

Opinions and interpretations rendered by attorneys in the Solicitor's Office and predecessor units on the establishment and running of unemployment compensation programs in the various states. The Department of Labor certified rules, regulations and procedures for grants to the states, but did so mainly in an advisory capacity. After most of the unemployment compensation programs were fully established, the Solicitor's Office assisted state offices in litigation efforts and acted as a clearing house of information with other unemployment and social security bodies. Another main task performed by the Solicitor was to certify that state unemployment compensation laws were in conformity with the legal requirements of Sec. 303(a) of the Social Security Act.

12. Case File for Teamsters vs. Secretary of Labor Wirtz. c. 1 cu. ft.

Investigative case file for Teamsters vs. Secretary of Labor Wirtz consisting of internal correspondence, official proceedings, and court rulings and orders. This investigation was conducted under the Labor-Management Reporting and Disclosure Act (1959) that required annual financial reports from both union officers and attorneys or agents working for the employers who were hired to "educate" employees about the unions and their own welfare. The Solicitor's role in the enforcement process under the Act varied from full litigation to punish wrongdoing to investigating allegations of wrongdoing and making this information available to

officials and "interested persons". This last privilege of making information known was tested in the case of the Teamsters vs. Secretary of Labor Wirtz when Jimmy Hoffa did not want it known that he had used union funds to defend himself against civil and criminal charges in federal courts. The courts ruled in favor of the Solicitor's right to both investigate and make known his findings; Hoffa was forced to return some of the Union's monies to save face with his membership.

32. Selected Compliance Review Files, 1965-85. 25 cu. ft. Arranged by industry type, thereunder by year, and thereunder alphabetically by the name of the company.

Compliance reviews were investigations conducted by OFCCP of companies in the construction or supply and service industries that contracted with the federal government to determine if they met with federal equal opportunity regulations. The reviews could be instigated at the complaint of a company worker or by the OFCCP. If problems were found, the OFCCP could prosecute the company or negotiate an agreement and would make follow up investigations to monitor the company's progress. The files include correspondence, memoranda, contracts, EEO-1 reports, affirmative action programs, standard compliance review reports, conciliation agreements and other documentation. The Bethlehem Steel Case was one of the original contract compliance cases. It has been singled out by Labor Department

officials as one of the most significant civil rights cases that they have handled. Accession 70g6587 contains another important early case, the Crown Zellerback Case. This case was first handled by the committee on equal opportunity, but the settlement they negotiated was rejected by the black local union since the highest step on the promotion ladder for blacks was lower than the lowest step for whites.
