1. Middle East Peace Process Files, 1956 - (Project Attica Files)

Consists of all background information, discussions, briefings, minutes of meetings, talking points, internal correspondence, etc. that accumulated prior to and including the final peace agreements between Israel and Egypt in which the United States was the mediator. Files are arranged chronologically.

Permanent. Retain in NEA until no longer needed or one year after the peace process is completed. Retire to OIS/RA/RSC for transfer to WNRC after 2 years. Transfer to the National Archives when 30 years old.

2. Maps - Arab-Israeli Borders

Maps pertaining to borders of Israel and neighboring countries that identify agreed demarcation lines and proposed adjustments to the borders.

Permanent. Retain in NEA until no longer needed or one year after the peace process is completed. Retire to OIS/RA/RSC for transfer to WNRC after 2 years. Transfer to the National Archives when 30 years old.
