**PERMANENT.** Transfer to the National Archives immediately. ✓

**Appraisal:** Within the international information program, these records are the highest level documentation of the U.S. international broadcasting program. As such, they contain unique and important documentation relating to the overall policy and direction of that program during the early years of the Cold War. They are similar to other IIA records that have been designated as permanent. These files will also fill gaps in the existing files on the Department of State's stewardship of the international information program. ✓

2. VOICE OF AMERICA (VOA) HISTORICAL FILES, 1946-1952

Arranged by subject. Memorandums, scripts, notes, chits, clippings, correspondence, reports, minutes of meetings, speeches and statements, and other material relating to the post-World War II continuation of the Voice of America (VOA), management and direction of the program, and controversies surrounding its programming.

**PERMANENT.** Transfer to the National Archives immediately. ✓

**Appraisal:** These files contain unique and important documentation relating to the history of the Voice of America. Specific topics include the VOA effectiveness, jamming, programming, and the MacArthur controversy. They complement the records covered by Item 1 and like them fill gaps in the existing files on the Department of State's stewardship of the international information program. ✓

**Appraisal:** These files include unique and important documentation relating to the establishment of policy and programs aimed at the Near East and South Asia. Included are files on audience surveys and the Working Group on Materials for Arab and Other Moslem Countries. They are a useful complement to the records covered by Item 4, and like them, fill gaps in the existing files on the Department of State's stewardship of the international information program. ✓

#### 6. COUNTRY REQUESTS FILES, 1948-1953

Arranged by name of city. Correspondence, despatches, Operations Memorandums, and telegrams relating to requests for and shipping of copies of VOA recordings.

These files complement those covered by Item 1, and like them fill gaps in the existing files on the Department of State's stewardship of the international information program. ✓

Arranged by country and subject. Memorandums, telegrams, reports, notes, chits, and other material relating to the status of transmitting stations.
