These files were originally selected for permanent retention under Job No. NN-171-141, Item 25 which called for the retention of a representative sample of case files. I recommend that these records be scheduled for immediate destruction. While they do provide information on the establishment, amendment, extension, or cancellation of programs, there is no real substance to these files. The issues dealt with are primarily routine and facilitative in nature. The Bureau of Educational and Cultural Affairs was moved to the United States Information Agency in 1978. Similar records originating in that agency have been scheduled for destruction. Therefore, these records do not warrant preservation either.

Disposition: Destroy immediately.
