Dear Bill:

We completed our appraisal of the records on the SF 115 covering the Law of the Sea (LOS) negotiating files (NC1059-77-20), and have determined that only the memos of the NSC Task Force on the LOS are worthy of permanent retention by the Federal government. The subject files of the negotiators, the legislative files, and the D/LOS country files should be disposed of when administrative use ceases.

Since you described all of the series relating to the LOS under one item for which you requested permanent retention, we are returning the SF 115 to you without action. Enclosed is a draft SF 115 covering the temporary records. If you approve please sign the form and return it to this office. The memos should be scheduled with the other permanent records of the LOS Task Force.
