1.	<p>RECORDS OF PRESIDENTIAL APPOINTEE, WILLIAM C. FOSTER.</p> <p>The personal records of Presidential appointee William C. Foster consist of 14 boxes (14 cu ft) accumulated during the period 1958 through January 1969. These papers constitute a record of his incumbency as the Director of ACDA (a few papers cover his activities prior thereto). They contain documents, decisions, and proposals not fully covered or staffed in other agency records that are scheduled or to be scheduled for disposition. Among the materials are privileged communications from the President, the White House, other political appointees, sensitive Memorandums of Conversation (Memcons) with foreign emissaries; the U.S. officials on national policy, disarmament, arms control, and related agency missions. Included are appointment logs, telephone extracts, chron files, special case testimony before Congress, and related memorabilia. All of these are recommended for the appropriate Presidential Library as part of the White House history of that era. Some of the negotiations ACDA participated in during this period were the Limited Test Ban Treaty (1963), the Non-proliferation Treaty, the Hotline Agreement, and the Eighteen Nation</p>		1 item
