1. Scientific Committee for Antarctic Research Files. These files consist of Operational Control Board (Department of State) Antarctic policy guidelines, operational plans, minutes of meetings, studies, reports, memorandums, and correspondence. The U.S. Geological Survey (USGS) accumulated these records through its participation in Antarctic activities as directed by the Operations Control Board Antarctic/National Security Council. The USGS's mission involved the mapping of America.

These records include reports and studies generated by the Department of State, the Central Intelligence Agency, and the Department of Defense. They are arranged by subject matter and report titles only. Within these categories they are not presently arranged either by date or in alphabetical order. The highest classification is "Collateral Secret." These records range in date from 1949 through 1970, inclusive.

Disposition: **Permanent**. Transfer immediately to the National Archives upon approval of this schedule.

Volume: Approximately 4 ½ cubic feet.
