Treasury Executive Office of Asset Forfeiture (TEOAF) Agent Website and Joint Operations System (AWS) Description: Treasury Executive Office of Asset Forfeiture (TEOAF) manages seized and forfeited assets for the Treasury law enforcement Bureaus, the United States Immigration and Customs Enforcement, Internal Revenue Service, United States Secret Service, and United States Customs and Border Protection. This system is designed to facilitate the processing of obligations and invoices related to the Joint Operations lead by the Treasury Forfeiture Fund and assists the above agencies in managing Joint Operations funds. The system facilitates on-line submissions of obligations/ invoices, automatic verification of their accuracy, and approval of these documents by TEOAF and the National Finance Center. This system also provides means for the managers to track and manage Joint Operations' funds. Background: This system is a web-based application hosted on the Treasury Department Network. Access to this system is limited to Treasury entities, the United States Immigration and Customs Enforcement, Internal Revenue Service, United States Secret Service, United States Customs and Border Protection, and the National Finance Center. Treasury Department users access the system directly, while other users access it by using Public Key Infrastructure (PKI). The records in this system are not classified, but are law enforcement sensitive. The records within this system are only released to the Federal agencies listed above.
