Background Information

The Return Preparer's (RPO) Competency Standards office oversees IRS competency tests for tax professionals. Prior to January 18, 2013, when the United States District Court for the District of Columbia enjoined the IRS from enforcing the regulatory requirements for registered tax return preparers (RTRP), a mandatory competency test for non-credentialed return preparers was required. However, in accordance with the Court's order, the IRS no longer offers this mandatory test. The voluntary tests to become an enrolled agent or enrolled retirement plan agent were not affected by the order.
