Background Information

The Foreign Accounts Tax Compliance Act (FATCA) was passed into law in March 2010 with the objective of improving the IRS's visibility into the overseas movements of income by US individuals and business taxpayers. FATCA requires US taxpayers to report certain types of financial accounts and assets held in Foreign Financial Institutions (FFIs), and other types of assets in Non-Financial Foreign Entities (NFFEs). In addition, FATCA requires FFIs and NFFEs to report on financial accounts and assets held by US persons, or face a

30% penalty on US-source payments.
