1	<p><b>Link and Learn Taxes System Data</b></p> <p>Disposition Authority Number      <b>DAA-0058-2017-0003-0001</b></p> <p>The Link &amp; Learn Taxes system is a learning tool used by IRS partners. It also has a certification instrument (test) which the user/volunteer takes to demonstrate their proficiency in providing tax return preparation assistance to taxpayers. System users must register with the system by creating user-name, password, and e-mail address. This information is then used by the user when logging into the system and kept in their account information. The registry would be valid for a single tax year. Volunteers who are certified through the Link and Learn certification instrument will have the data accumulated and available to the affiliated volunteer organization, and a listing will be available by Area and Territory. Each Territory can obtain a report of the volunteers in their Territory who have been certified through testing. The testing instrument and volunteer registry update only need to be maintained for one tax year.
