These are Rights and Interests Records.</p> <p><u>Background</u> This form is produced in Large and Mid Size Business (LMSB), Office of Tax Shelter Analysis (OTSA), Pre-Filing and Technical Guidance (PFTG), and is a Reportable Transaction Disclosure Statement. Forms are numbered consecutively. Each form receives a unique identification number (OTSA ID), the first two digits of which indicate the year the form was received. As an example, a Form 8886 received in 2005 would disclose information for a reportable transaction in which the taxpayer participated in Tax Year 2004.
