### Partnership Control System (PCS)

### Background:

The Partnership Control System (PCS) is a database designed to control and monitor flow-through entities and linked investor returns. It does not replace AIMS inventory control, but it provides the additional information needed to control investor and flow-through returns. It Interfaces with the Audit Information Management System (AIMS) to establish returns, access information, and provide mass updates to AIMS

PCS allows an unlimited number of investors to be linked to each key case or tier and allows an investor to be linked to an unlimited number of flow-through entities. The linkage charges the returns to the appropriate area office or CTF. In addition, it places the flow-through entity PICF Code 2 on the key case on AIMS and Examination Returns Control System (ERCS) databases It also places an investor PICF Code of 6 on AIMS and ERCS databases so that any other part of the service can see that an entity related to the investor return is under examination. This prevents premature closure of an investor return until all key case issues are resolved. It should also prevent improperly restricted statute extensions

It also provides the capability to control and monitor partnership and related individual returns being examined.
