Background:

The IRS uses the weekly U.S. Postal Service National Change of Address (NCOA) database to update the Individual Master File (IMF). The Taxpayer Address Request (TAR) extract is created using a list of state-supplied Social Security Numbers (SSNs) and name controls submitted via a tickler file.

Primary and secondary Social Security Numbers (SSNs), as well as the taxpayer's name and address are extracted and provided to participating agencies. In addition, data from the latest tax module year is provided to establish accuracy of the information.

Description:

Taxpayer Address Request (TAR) System is used to extract the latest taxpayer address on the Individual Master File (IMF) and provide to various state and federal agencies that are certified to receive this information. These requests are submitted to the Internal Revenue Service (IRS) by the participating agencies.

a. Inpluts:

Includes data extracted from the Individual Master File (MF).

Disposition: Temporary. Note - The Individual Master File (IMF) is a scheduled record under IRM 1.15.29. Information extracted from the IMF can be deleted/destroyed upon verification or when no longer needed.

b. System Data:

The Taxpayer Address Request (TAR) System contains individual records from the IR Forms 1040 series. This information is extracted from the Individual Master File (IMF)

Disposition: Temporary. Destroy when 5 years old or when no longer needed for operational purposes whichever is sooner.

NEW

Includes TAR extracts that are distributed on a periodic basis as requested by participating agencies. Disposition: Temporary. Destroy when obsolete, superseded, or no longer needed for business, whichever is later. d. System Documentation: Includes user guides, record layouts, file specifications, computer operator handbooks, and other similar documentation. Disposition: Temporary. Delete/destroy when

superseded or 5 years after the system is

terminated, whichever is later.
