


A. Inputs:

Inputs to the Executive Control Program for BMF Extract (BMF 701 EXEC) are extracted from the IBM Mainframe and Business Master File (BMF)

Disposition: TEMPORARY. Delete/destroy cache file after successful entry and verification into the system. GRS 20/2

B. System Data:

The Executive Control System (BMF 701 EXEC) maintains BMF data on taxpayers extract from the Business Master File

Disposition: TEMPORARY Delete/destroy when no longer needed for operational purposes

C. Outputs:

Outputs of the Executive Control Program for BMF Extract (BMF 701 EXEC) consist of reports and data extracts (transcripts of accounts)

Disposition: TEMPORARY Delete/destroy when no longer needed for operational purposes GRS 20/5, 12a, 16

D. System Documentation

System Documentation for the Executive Control Program for BMF Extract (BMF 701 EXEC) consists of codebooks, records layout, User Guide, and other related materials.
