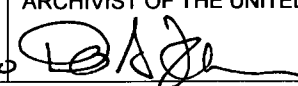
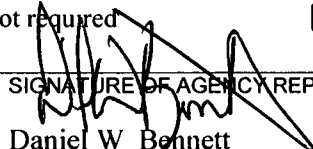

Report Generation Software (RGS)

Background:

Report Generation Software (RGS) is an Internal Revenue Service (IRS) application/system that has been categorized as a Major Application RGS currently resides at selected IRS Service Centers (SC) Campuses and Area Offices (AO) on Windows 2003 platform and has been deployed since 1988.

RGS is a comprehensive, integrated program used to automate the examination process. It provides inventory, computations, workpapers and correspondence for examiners as well as an electronic download of Return Transaction File (RTF) return data, electronic upload of assessment and closed case data to the Audit Information Management System (AIMS) and Integrated Data Retrieval System (IDRS), and electronic archiving of closed cases

RGS is a Graphical User Interface (GUI) based system that provides support for all types of examiners. Wage and Investment, Small Business/Self-Employed, Tax-Exempt & Government Entities, and Large and Mid-Sized Businesses W&I developed RGS/Batch as an enhancement to RGS to allow for automated processing of large volumes of 1040 cases, primarily Earned Income Tax Credit (EITC) inventory, through the examination process RGS/Batch provides an automated case processing environment that relieves tax examiners of the time-consuming, repetitive task of setting up case files and generating the taxpayer reports and letters in RGS for routine cases.

The business objectives for RGS include, improving the case product sent to the taxpayer, reducing computational errors, and reporting correct closing information to the states through Examination Operational Automation Database (EOAD).

Description:

The RGS Data Store contains inventory, computations, workpapers and correspondence for tax examiners as well as Returns Transaction File (RTF) return data, assessment and closed case data.

a. Inputs:

Information can be manually entered into RGS by a user or downloaded from a server. The information is in the form of the tax return as originally filed. The data is entered/displayed in Return Setup.

Disposition: Temporary. *Note* - The Individual Master File (IMF)/Individual Transaction File (IRT) are scheduled records under IRM 1.15.29.

Information extracted from the IMF/IRT can be deleted/destroyed upon verification or when no longer needed. Delete/Destroy all cached records after successful entry and verification.

b. System Data (Master Files):

The RGS System maintains correspondence sent to the taxpayer, the examination report, case workpapers, case history document, and case closing record.

Disposition: Temporary. Cut off at close of case. Delete 15 years after cutoff.

c. Outputs:

Include numerous reports that can be printed to assist tax examiners and managers to monitor individual tax examiner inventories, weekly receipts, case updates, unit inventories, section inventories, and branch inventories.

Disposition: Temporary. Destroy/Delete when superseded, obsolete or no longer needed, whichever is later.

d. System Documentation:

The RGS application was developed by third party contractors. As part of the development process, extensive documentation has been developed to cover all aspects of the application. All RGS component documentation is maintained by the Dallas
