**Background.**

*LB&I 1446-6 International Database (LB&I 1446-6) supports compliance activities in support of Partnership Withholding (Section 1446) regulations. The function of this application is to capture information submitted by Foreign Partners of Partnerships. The partners file Project 1446-6T certificates. Alternate names for this system are Withholding Certificates 1446-6T, the 1446-6T Withholding Exemption Certificates Project, or Project 6T. The LB&I 1446-6 application 1) stores the information from the certificates in a database, 2) interfaces with IDRS (Integrated Data Retrieval System) to validate the data submitted on the exemption certificate, and 3) provides the capability to generate taxpayer letters (soft letter or strong letter determined by criteria of the regulations). The official IRS form letters are mailed to taxpayers (commonly known as "Project 6T Letters"). The "soft" letter affords the taxpayer the opportunity to amend/resubmit a completed certificate within a prescribed timeframe. A "strong" letter advises the taxpayer that the information they provided does not support their request for reduced 1446 withholding tax, as a result, the certificate is considered "defective" and they must adjust the Section 1446 tax to include the income originally reduced by the certificate. The application also provides Headquarters LB&I Research with data of all 6T files contained in the database.*
