


Background.

The Chapter Three Withholding (CTW) Database processes Forms 1042-S (Foreign Person's U S Source Income Subject to Withholding) and Form 1042-T, Annual Summary and Transmittal of Form 1042-S Forms are submitted on paper or transmitted electronically to the FIRE system at the Enterprise Computing Center (ECC) Martinsburg Paper 1042-S and 1042-T forms are sent to the Ogden campus They are processing as transcribed at the Ogden Campus Both paper and electronic data are perfected at the Ogden Campus Valid and perfected 1042-T and 1042-S data are transmitted to ECC-Martinsburg for posting to the IRP and Payer Master Files At the end of CTW processing, all CTW data is extracted to a CTW research table This research table is used to produce the Organization for Economic Cooperation and Development (OECD) files Those files are written to CDs, which are mailed to foreign governments Data from this research table is shared with Statistics of Income

The purpose of this system is to correct Form 1042-T and 1042-S records that have failed validity, consistency checks, or math error computations through the Chapter Three Withholding database The Chapter Three Withholding Database is an on-line correction process in a real-time environment The Chapter Three Withholding (CTW) Database will display both paper and electronically filed returns that have not passed validity, consistency checks, or math error computations Input Correction correct errors on the CTW app server and are then saved to the database

Chapter Three Withholding (CTW) Database

Description:

The Chapter Three Withholding (CTW) Database is an application that captures tax information related to foreign individuals and entities (e g foreign partnerships, corporations, etc) The tax withholdings are reported on various tax international returns prepared by or for those foreigners or foreign entities, and then submitted to the IRS

A. Inputs

Inputs to the Chapter Three Withholding (CTW) Database are manual corrections or are electronically derived from UNPOST_T_DATA_FILE from PMF, PAPER_T_DATA_FILE from ISRP, PAPER_S_DATA_FILE from ISRP, ELECTRONIC_T_DATA_FILE from FIRE (Filing Info Returns Electronically), and ELECTRONIC_S_DATA_FILE from FIRE

The Chapter Three Withholding ((CTW) Database is used to correct information and resolve errors on tax withholding issues. Outputs are corrections to various transactions, matching, data, and reporting systems and applications.

The Chapter Three Withholding (CTW) Database is designed to correct Form 1042-T and 1042-S records that have failed validity, consistency checks, or math error computations through the Chapter Three Withholding (CTW) Database

- 1 Unresolved electronic 1042-S information records

Disposition TEMPORARY Move to the 1042-S "Junk" Table Destroy electronic data on, or after, January 15 of the year after processing

- 2 Backup Tapes of resolved and corrected 1042-S information records
