


The reconciliation report is used to alert the service center, CFO, and SP HQ of any imbalances between Trace IDs and any processing problems within the service center. The report lists all Trace IDs received for an accounting period.</p> <p><b>DISPOSITION: TEMPORARY. Cut off at the end of the FY. Retire to Federal Records Center after 18 months of on-site storage.
