Consists of photo prints, slides, negatives, etc. of various Mint activities, facilities, equipment and Mint products (coins, medals, etc.) from the Mint Historian's office and in Mint records storage areas. These will be transferred to the National Archives in small batches as information adequate to identify them is gathered. Due to the age of some of the items it is not deemed desirable to hold them until a full box is prepared for shipment. Any items not required or deemed appropriate for permanent retention by the National Archives should be returned to the United States Mint for use as reference copies.</p> <p>DISPOSITION: PERMANENT. Transfer to NARA in Small groups (with indices) until all photographic items dated prior to the year 2000 in the Historian's office and Mint records storage areas have been transferred to the National Archives.
