WNRC acc. 195-70-A-3148.</p> <p>These records document the Home Owners' Loan Corporation's purchase of shares in various savings and loan associations under authority granted in the Home Owners' Loan Act of June 13, 1933. The funds received from the sale of shares were used by the associations to finance new housing in their communities. The shares were later repurchased by the associations from the Corporation.</p> <p>The records are arranged numerically by docket number. Records include requests for share purchases, analyses of associations' financial condition, requests for the repurchase of shares, along with other documentation relating to the transaction.
