Background Information

The Bureau of Engraving and Printing commonly generates during the intermediate stages of publication—for printing final products — images and related materials ranging from glass plate negatives, steel plates coated with light sensitive material and plastic base film negatives to offset lithographic materials to digital images. Such production images bear some resemblance, in functional terms, to the halftone negatives cited as non-permanent in the current General Records Schedule 6.4 (and the former GRS 21). Glass plates were used before the development of clear plastic based film. Silver salts, light sensitive material, were used to coat the glass. The glass was then exposed to light through a camera or contact process from an engraving and developed for use making press plates. Later the glass plates were used in a step and repeat machine to achieve a multiple image exposures onto a single sheet of plastic base film to be used making press plates. This process was used for both currency and stamps. Later with scanners and computers the images were scanned from a glass plate or engraving and output to film. Also, new electronic methods have the ability to process large format, multi-subject images and a large format, laser powered, film exposure. This process was then to output a single color, multi-subject film imposed to press specifications, including marks to make press plates. Now in the process of validation is the Computer to Offset Plate machine (Cop). The CToP has the ability to take the multi-subject image generated from the single-subject image that would have output to film and expose the image directly to the press plate. Nothing in the process changes with the exception of the need to output the image to film. This process is now used for test work and not for production.
