Background Information The United States Currency Program (USCP) is a combined Treasury, Federal Reserve and United States Secret Service effort that was formed to coordinate counterfeit deterrence activities of the government agencies involved in United States currency production efforts. It is composed by multiple interagency committees; Advance Counterfeit Deterrence Committee (ACD), Interagency Currency Committee (ICC), Program Approval Committee (PAC) and Technology Approval Committee (TAC). The Advance Counterfeit Deterrence (ACD) Steering Committee was formed in Jul 1982 to coordinate the counterfeit deterrence activities of agencies involved in the effort.
