Background Information **The Surety Bond Branch (SBB) administers functions relating to the qualification of insurance companies as acceptable sureties on bonds running in favor of the United States, including the qualification of acceptable reinsurers of such companies as well as Pools and Associations and Lloyds' of London (31 U.S.C., 9304-9308).**

SBB receives and processes applications submitted from corporate sureties (insurance companies) requesting consideration for issuance of a Treasury Certificate of Authority to direct write and/or reinsure bonds running in favor of the United States. This includes examination of statutory financial statements, actuarial opinions, reinsurance treaties, independent certified audit reports, state insurance department examination reports, underwriting policies and procedures, operational procedures, managerial expertise and safety and soundness. The reviews facilitate the determination and assignment of underwriting limitations for the surety companies and aid in the protection of Federal agencies and taxpayer funds.

Utilizing the Surety Information Management System (SIMS), SBB assures the timely processing of applications, as well as the qualification of applicant companies to be accorded Treasury certification. Similarly, the branch processes applications from companies requesting recognition status as Admitted Reinsurers, except for excess risks running to the United States. SBB assists agencies in their daily transacting of business with surety companies in the areas of normal bonding and reinsurance activities, fraudulent activity, and when agencies encounter difficulty with sureties, whether it be on matters such as the interpretation of regulations or in the area of claims. It provides guidance to Government agencies and federal contracting officials, state and local government officials, commercial enterprise and the general public,

regarding all aspects of Federal surety bonding requirements and related issues.

The Treasury Department Circular 570 is published annually July 1, listing all acceptable sureties and reinsurers on Federal bonds. The list of Admitted Reinsurers, Pools and Associations, and Lloyds' of London Syndicates is published annually on September 30.
