NOTATING THE CHANGES: The "Summary of Changes from previous submission" field includes a drop-down list of possible changes that may have occurred since the previous submission. This field helps facilitate review of the new submission by NARA. Please select the scenario that is most appropriate. Most positions being carried forward from a previously approved form can likely be noted as "No change." Other changes may include: number of positions increased / decreased (generally for those position titles that are rolled-up); number of accounts increased / decreased; the title of the position has changed; the position is new to the agency (and thus was not on previously approved forms); the position has been moved from one category to another (for example, a position was approved as Category 2 in a previous submission, but was deemed more appropriate for a different category; or the position has been reappraised as permanent (was not deemed appropriate for inclusion on previously approved forms, but now is). 3rd Party Communication applications such as SIGNAL, What's App, etc, are not utilized for standard FinCEN communication applications are not installed by default on FinCEN devices and cannot be installed by end-users..

In extremely rare cases as this is not a routine occurrence, a request to utilize a 3rd party communication application for a limited amount of time may be made and requires executive approval. Under that approval, the end-user agrees to:

- (1) the time limited duration of the application availability,
- (2) the removal of the application after the requested period of use, and
- (3) forward any FinCEN or Treasury-related messages to non-encrypted FinCEN messaging systems within twenty (20) days typically this requires the end-user to copy such messages into a standard email and send to their FinCEN email account. The Service Desk can walk the end-user through this process, as necessary.

Once the 3rd party communication application is removed from the device, the data associated with that application are removed as a result of the uninstallation.
