1	Records Related to the Bragdon Study. 1959-60. Ca. 1 cu.ft. Reference file maintained by a F.C. Turner, a Bureau of Public Roads employee involved in Bureau input to the study. (The Study was a review carried out by Maj. General John S. Bragdon, Special Presidential Assistant in Charge of a White House Study Committee looking into the highway system in the U.S., especially highway construction funding in urban and industrialized areas. The Bureau of Public Roads was apparently involved to the extent of furnishing Bragdon with reference information and commenting upon his findings. The records consist of carbon copies of letters from Bragdon and the Department of Commerce, requesting information from the Bureau about the highway system; a small amount of newspaper clippings; copies of reports used as reference material; and portions of an interim report on the Study, with some Bureau commentary. The records were offered to NARS under <u>Accession Job NC3-30-80-13, series 1</u> , and were found to be disposable for the following reasons: this is a reference file, incomplete, mostly transmittal material; similar material about the study, including some material that duplicates what is in this file, will be coming to NARS in the Bureau of Public Roads Central Correspondence File which NCD recently appraised; the Eisenhower Library maintains a collection of Bragdon's papers related to the Study, and that material		<i>8 items</i>

This information is duplicated in the published Bureau annual reports for 1947-58; "status of postwar Federal-Aid Highway Funds, July 31, 1948." This information is also duplicated in Bureau annual reports; "Roads and Streets in the US at the end of 1947." Information is very limited, and paper does not indicate period covered. 3	<p><u>Miscellaneous Documents Regarding Maintenance of Roads.</u></p> <p>"State maintenance cost data, 1906-23," consists of information apparently put together for reference purposes by persons unknown from a variety of published sources from each State. The material does not indicate in what year it was compiled or for what purpose, and is of no research value; 1 binder labelled "#1 Annual Maintenance Costs Special Studies Sections," no date; "summary of annual maintenance cost for [ State name ] special study sections CY [ 1934, 1935, 1936, and/or 1937--not all years for all States ] by surface types"; 1 binder containing same "summary" sheets for Ohio thru Wyoming, for 1924-9, not all years for all States. This information appears to be available in a report ("Report of the Cost of General Highway Maintenance and Related Data"), which MNHP is now appraising for permanent retention. 5	<p><u>Legal Papers Related to the Bureau of Public Roads.</u> This series consists of the following: 1) mimeographed copy of a Brief for Appellee USA before the Appeals Board, US Dept. of Commerce, concerning an Arizona Forest Highway Project, 1960; 2) mimeographed copy of a Brief of Appellee USA before the Dept. of Interior Board of Contract Appeals concerning the Blue Ridge Parkway project; 3) mimeographed copy of a summary of actions concerning an appeal, 1961; 4) and "Brief of Legal Authorities Prepared for Presentation to the Committee on Land Acquisition and Control of Adjacent Areas of the Highway Research Board," 1951. These are only a small portion of all reports done for this project, and all information is summarized in "War Worker Transportation," which NARS will accession under NC3-30-80-7.
