Background Information            The Traffic Flow Management System (TFMS) provides information processing support for Federal Aviation Administration (FAA) traffic management personnel as they coordinate the use of the National Airspace System (NAS) and respond to conditions of excess demand. TFMS receives information on planned and active flights, generates forecasts of demand from current time to several hours ahead, presents this information to Traffic Management Personnel, and provides automation support for the traffic management initiatives to resolve or ameliorate congestion.

TFMS supports advanced planning for anticipated adverse or restrictive conditions. It supports post-event analysis and evaluation of actions taken. TFMS archives the information it receives and generates, making it available for researchers and developers. It collects and distributes metrics on the use of the NAS and the contribution of Air Traffic Organization (ATO) to air traffic efficiency and effectiveness.
