Background Information

This record schedule covers surveys and collection mechanisms for special use studies that are conducted on matters within the authority of the FAA to prepare compilations of statistical activities, reports, and data of studies. Surveys and other collection mechanisms are used to collect information periodically in most cases; however, offices may request special studies at other intervals. These collections are conducted under the confidentiality of respondent or participant information which will be protected once data is received. Examples of surveys include, but are not limited to, Neighborhood Environmental Survey (and analysis of aircraft noise annoyance), National Sleep Survey, Safety Alerts for Operators Survey, Lead Abatement Project Surveys, and Facility Occupational Health Surveys as well as other surveys and special studies conducted by the FAA in an effort to protect the flying public and in the conduct of our day-to-day operations. These surveys are one-off surveys done on an as needed basis to conduct analysis on studies.
