Background Information The ADS-B SAPT predicts whether the GPS constellation will support, for a particular route of flight and avionics, position information which has the needed accuracy and integrity for surveillance (ADS-B) or navigation (RAIM).

 The Federal Aviation Administration (FAA) finds it is necessary that pilots, dispatchers, and commercial operators meet the minimum position accuracy and integrity performance requirements to operate in ADS-B-designated airspace.

 SAPT is an Internet-accessible (web-based) application with multiple interfaces for predicting, for a given flight plan, whether or not an ADS-B surveillance meeting specified standards are available for the duration of the flight. The SAPT prediction is based upon: (1) the time, route, and airspace of the planned flight; (2) ADS-B-related avionics on the subject aircraft; and (3) the announced status of the Global Positioning System (GPS) satellite constellation. If the GPS position is not accurate enough for ADS-B surveillance, SAPT can check for backup surveillance.
